

**RESOLUTION # 16-06**

**RESOLUTION OF THE BOARD OF COMMISSIONERS AMENDING THE RULES AND REGULATIONS MANUAL (RESOLUTION 15-07) TO INCREASE CUSTOMER SECURITY DEPOSITS BY \$75 TO \$325.**

**WHEREAS**, the Board of Commissioners of the IMMOKALEE WATER AND SEWER DISTRICT (hereinafter referred to as the "Board") is empowered to construct, operate and maintain a Water and Sewer System (the "System") as described in Florida Statute Chapter 78-494, Laws of Florida, which was amended by chapters 93-366, 94-489, and 95-492, Laws of Florida, was codified, reenacted, amended, and repealed as Chapter No. 98-495, was amended in Chapter 2005-298; and was amended in Chapter 2015-205; and

**WHEREAS**, the Board is authorized and empowered to make rules and regulations for its own government and proceedings; and

**WHEREAS**, the Board recognizes that they have increased water and sewer rates, and that they need to increase security deposits to cover the higher monthly costs, and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE IMMOKALEE WATER AND SEWER DISTRICT**, in public meeting assembled that the following changes to the Rules and Regulations be implemented:

Security Deposit – Commercial	\$325.00 (per EDU)
Security Deposit – Residential	\$325.00 (per unit) *

\*New applications for service involving a multi-family dwelling or facility served by one meter will be charged for a security deposit based on the meter size instead of the Equivalent Dwelling Unit (EDU). This will only apply in unit sizes of four or more separate living areas.

This resolution shall become effective on May 1, 2016.

If any phase or portion of this Resolution is held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portion.
